Request:

- 1. Could you please tell me the PCC's annual salary and whether this has remained the same since the post was created in 2012?
- 2. How many members of staff did your office have when it was created in November 2012, and what was the annual salary cost at that time?
- 3. How many members of staff does your office have as of now, January 2020, and what is the current annual salary cost?
- 4. How many members of staff are paid an annual salary of more than £100,000 as of now, January 2020?
- 5. How many members of staff has the office employed since November 2012 and what is the total salary cost of this?

Clarification:

Question 5 was clarified to read as follows:

I would like to know how many different members of staff have worked in the office since it began and the cumulative sum of all their staff salaries combined.

Response 1:

I can confirm that the Office of the Police and Crime Commissioner (OPCC) does hold the requested information, as outlined below:

As at the date of your request, the Police & Crime Commissioner's (PCC's) annual salary is £66,300. I can confirm that the PCC's annual salary was £65,000 as at 2012. The increase in salary was implemented in 2018.

Response 2:

I can confirm that the Office of the Police and Crime Commissioner (OPCC) does hold the requested information, as outlined below:

November 2012: Total of 8 staff (headcount)

Annual Salary Cost: £298,721.38

Response 4:

I can confirm that there is no information held by the Office of the Police and Crime Commissioner (OPCC). This is as a result of the fact that no members of staff are paid an annual salary of more than £100,000 as of January 2020.

Response 5:

I can confirm that the Office of the Police and Crime Commissioner does hold the requested information concerning the number of staff employed since 2012, as outlined below:

A total of 70* members of staff (headcount) have worked in the office since it began in 2012

*Please Note: The above figure includes the Estates Department that transferred from Dyfed Powys Police to the Office of the Police and Crime Commissioner in the 2017/18 financial year – 31 staff members (headcount). The above figure also includes 4 (headcount) salaried student placements. The above figure does not include the role of the Police and Crime Commissioners over the time period requested.

I can confirm that the Office of the Police and Crime Commissioner does hold some of the requested information concerning a breakdown of staff salaries; however this information is retained for 7 financial years (including the current financial year) and therefore there is no information held concerning the 2012/13 or 2013/14 financial years.

A breakdown of the staff salaries between 2014/15 and the current financial year is outlined below:
