Crynodeb Gweithredol:

Deilliodd Rhwymedi Cymunedol o ymgynghoriad cyhoeddus a gynhaliwyd gan y Swyddfa Gartref yn 2012-2013. Ar ôl derbyn cefnogaeth gan y rhan fwyaf o ymatebwyr, daeth y Rhwymedi Cymunedol yn elfen allweddol o Ddeddf Ymddygiad Gwrthgymdeithasol, Troseddu a Phlisma 2014.

Cynhaliodd Swyddfa Comisiynydd Heddlu a Throseddu (SCHTh) Dyfed-Powys ymgynghoriad cyhoeddus yn 2013, a chytunwyd ar ddewislen rhwymedi cymunedol.

Ers 2013, mae SCHTh, mewn ymgynghoriad â Heddlu Dyfed-Powys, wedi diweddarau'r ddewislen rhwymedi cymunedol mewn perthynas â diwygiadau i brosesau mewnol sy'n gydnaws â phob dewis; fodd bynnag, mae cynnwys y ddewislen rhwymedi cymunedol yr un fath ers 2013 h.y. 10 mlynedd.

Argymhelliad:

1. Cynnal ymgynghoriad angenrheidiol ar ddewislen rhwymedi cymunedol newydd.
2. Creu tudalen benodol ar wefan SCHTh Dyfed-Powys.
3. Cyhoeddi canlyniad yr ymgynghoriad cyhoeddus ar y dudalen benodol ar y wefan.
4. Creu dogfen swyddogol sy'n amlinellu rhestr o ddewisiadau rhwymedi posibl, fel y cytunwyd o ganlyniad i ymgynghori.

Title: Community Remedy Options/Menu

Category of Decision / Business Area Impact: Public Consultation

Executive Summary:

Community Remedy derived from a public consultation in 2012-2013 run by the Home Office. After receiving support from a majority of respondents, the Community Remedy became a key element of the Anti-Social Behaviour, Crime and Policing Act 2014.

The Office of the Police and Crime Commissioner (OPCC) for Dyfed-Powys undertook a public consultation during 2013, where a community remedy menu was agreed.

Since 2013, the OPCC in consultation with Dyfed-Powys Police, have updated the community remedy menu regarding internal process revisions aligned to each option; however, the content of the community remedy menu has remained the same since 2013 i.e. 10 years.

Recommendation:

1. Undertake necessary consultation on a new community remedy menu.
2. Create a dedicated page on the Dyfed-Powys OPCC website.
3. Publish the outcome of the public consultation on the dedicated website page.
4. Create an official document outlining a list of potential remedy options, as agreed as a result of consultation.
