RE: HMICFRS PEEL Efficiency Inspection 2017

I welcome the latest report on Efficiency in Dyfed-Powys Police and am pleased to see evidence of the Force's improved understanding of demand, which is testimony to the hard work and commitment of Officers and Staff and the leadership of Chief Constable Collins and his team.

As detailed within my Police and Crime Plan I am committed to fostering strong positive leadership skills across all levels of the organisation by investing in our staff to develop their skills, experience and abilities. My plan also commits myself and the Chief Constable to identifying and developing talent to ensure that the right people are in the right posts at the right time. This, coupled with succession planning, is an area of work which I am paying particular attention to through my regular accountability meetings with the Chief Constable.

The Force has continued to develop its talent management scheme and has expanded to offer additional career development opportunities to a wider group of staff members. Progress is also being made to introduce apprenticeships into the Force to broaden recruitment opportunities. My office is currently advertising for its first apprentice.

In recognition of the need for a workforce who can better connect with our Welsh-speaking residents, I am currently exploring options with the College of Policing and Welsh education partners to improve the offer to Welsh recruits the opportunity to undertake their training through the medium of Welsh. I am also pleased to see the Force's increasing recruitment of Welsh-speaking staff and officers, as well as their commitment to providing a wide range of training to existing staff to improve their Welsh language skills. We have recently had a positive audit by the Welsh Language Commissioner which found the service we provide to our Welsh-speaking residents is of a high standard.

I am confident in the Force's leadership team and their approach to addressing the areas for improvement identified through HMICFRS inspections. My office maintains oversight of progress made through attendance at Force governance meetings and our scrutiny work focuses on key areas for improvement to support the Force's progress towards an enhanced service to the public of Dyfed-Powys.
