These notes provide a summary of discussions and actions set at the second meeting of the PCC's Select Committee.

1. Apologies, introductions, and membership

Apologies were shared and introductions made. The PCC welcomed new members onto the Select Committee.

2. Ratification of Minutes

The Minutes of the first Select Committee meeting of 7th May 2025 were accepted as a true and accurate reflection of the meeting. The Minutes will be translated and published on the PCC's website.

The ten actions taken at the meeting of 7th May were discussed. The PCC confirmed just two remain 'in progress'; both relate to the planning of engagement activity. All other actions were marked as 'complete' and featured on the agenda for this meeting.

3. Working Group update on tasks from previous meeting

At the May meeting, Select Committee members raised several queries and requested additional information to guide them in their decision-making. Following the meeting, Committee members were provided with a document relaying the relevant information and clarification as requested.

In addition to this, Census data conveying the population of 18–25-year-olds across the DPP area, as well as a breakdown of criminal offences committed by 18–25-year-olds, was shared with Members.

They were also provided with a document setting out crime and anti-social behaviour (ASB) intervention, prevention, and engagement best practice in areas across the UK, identified by the Working Group. Members commended the work being undertaken and reiterated the importance of identifying local best practice.

The PCC led a discussion on data: Reoffending data in terms of its availability and how such data could evidence the success of crime and ASB intervention, prevention, and engagement services; and the proportion of crimes committed by 28-25-year-olds.

Action 11: Working Group to glean a wider understanding of reoffending data captured by service providers.

Action 12: Working Group to further consider the proportion of each crime type committed by 18-25-year-olds, and the location of the crimes.

Action 13: Working Group to discuss with Dyfed-Powys Police, the development of a Problem Profile for crimes committed by 18-25-year-olds.

4. Proposed witnesses and questions for first Hearing

The PCC led a discussion on whom the Select Committee ought to invite to give evidence at the first Select Committee Hearing.

Action 15: Working Group to confirm the approach to be adopted in the submission of evidence at the Hearing.

5. Engagement plan

The PCC's Engagement Advisor updated Committee members on the threepronged approach to engagement activity:

- i. A survey for young people,
- ii. An open call for evidence for key stakeholders and the public, and
- iii. A series of focus groups.

Action 16: Working Group to share draft engagement documents with Select Committee members. Members to consider the wording and approach and provide feedback to the Working Group.

6. Any other business

No further business was put forward.

7. Next steps

The Chair summarised the next steps of the review:

- The Working Group will progress actions set at this meeting.
- The engagement activity will launch mid-June.
- Invitations for the Hearing will be disseminated by 13th June.

The timeline for the Select Committee review will be updated and shared with members.

8. Date of next Meeting/Hearing

The Select Committee will next meet on the 25th of June to confirm the plans for the first Select Committee Hearing which will take place in-person on the 16th of July 2025, 13:00-17:00. Venue to be confirmed.
